The Police Department is requesting an appropriation funds, totaling \$88,451.00, from Other Revenue 0751-0017-00-390.010, to Purchase of Vehicles 0751-0017-04-444.080.

These funds are received from the sale of decommissioned surplus vehicles via public auction.

- 23 decommissioned vehicles were sold February 22, 2022 via Wolfe's Auto Auction, receiving \$72,755.00 total revenue.

- 1 decommissioned ambulance (used by SRT medical team) was sold February 8, 2022 via GovDeals, a publicly available online auction company, receiving \$11,200.00 total revenue.

- \$846.00 balance remained in the Other Revenue 444.080 line at the start of 2022.

If approved, this appropriation would allow the police department to purchase several additional vehicles in 2022, ahead of the department's vehicle replacement plan schedule, further reducing maintenance costs of aging vehicles.
