Dear City Council Members,

I am writing this letter to bring you up to date on the success of the signature petition against the proposed rezoning of parcel #84-06-28-479-002.000-002, that Keri Yousif and I have collaborated on.

This letter contains 14 pages of 107 opposing signatures. All but 1 of these signatures are from residents of Farrington's Grove. Furthermore, most of these signatures are from residents that are in close proximity to the proposed construction site. Farrington's Grove is a historical family residential area, and includes many homes that are listed on the National Register of Historic Places. Placing a new construction dormitory degrades the neighborhood by the following:

1. It is not a home, as required by zoning; it is a dormitory.
2. The new construction would be right in between two historical buildings.
3. Parking that is already needed isn't available and a dormitory requires more parking.
4. It brings a concentration of recovering people to one residential location.
5. It is 3 blocks from an elementary school.
6. It brings much more traffic, i.e. service vehicles, friends, and relatives.
7. This lot is too small for the size of the proposed building. It would be crammed in.

Next Step alleges through Mr. Shagley that there is a hardship on the vacant lot as it now sits. However, Mr. Llewlyn has skillfully pointed out, that this argument doesn't hold water. In essence, what would really happen if S0 42 is approved, is that a hardship would then be placed on the residents of Farrington's Grove

Following is a list of all of the addresses, of the petitioners, that have signed the petition against the rezoning. The canvassing of signatures was mostly done the last week of November and early December. It didn't take long to get the 107 signatures, as many couldn't sign fast enough. We had 6 individuals that declined to sign. This showed us that 95% of the neighborhood residents, which we were able to contact, are against the rezoning. We begin by canvassing 5th, 6th, Center, and 7th Streets. We certainly considered doing the entire Grove, but it was clearly not necessary considering the response we had.
