I OPPOSE the closing of 27th Street between Wilson and Oak Streets.

My name is Susan Dean. I oppose the closing of 27th Street between Wilson and Oak Streets. Over 32 years ago, I bought my house. At the time, I knew my property lines, Oak Street to the north and 27th Street to the east. I was purchasing a corner lot. Twenty-seventh Street has been paved and labeled 27th Street by the city for nearly 100 years, if not longer. Neighbors have used 27th St. as a shortcut for those traveling to Baesler's Market, Memorial United Methodist Church, Meadows Mall, a walk around the neighborhood, and any location on the east side. The streets of 25th and 29th are much too busy to safely accommodate cyclists and dog walkers. Closing 27th St. effectively closes off Oak St. to our neighbors on Wilson and Crawford streets. Three of the four property owners living along this portion of 27th oppose its closing. In addition, my house has always had a carport. Because of the angle of the structure, it is nearly impossible and impractical to safely enter the shelter from any direction other than the south - driving along Wilson St., turning on 27th St., and entering my carport from the south. I want to continue using my carport! Finally, I want to thank the person(s) responsible for posting the notice. Without this sign, I am confident the vast majority of neighbors would not know the closing of 27th St. was imminent!
