Access to High-Quality & Affordable Childcare





- Childcare is a challenge in this region
- Workers want to engage in the workforce
- Families struggle to find needed services
- The American Rescue Plan Act to provide direct relief to cities and towns
- This request for ARPA funds will be used to facilitate greater engagement in the workforce

Indiana State University

Indiana State University's Early Childhood Education Center Expansion

- ISU Center is accredited by the National Association for the Education of Young Children (NAEYC) and licensed by the Department of Family and Children Services of the State of Indiana.
- The current location at Farrington and Third streets is at capacity (86)
- There is no room at that location to expand capacity
- Current waiting list of about 60-70 more children
- We maintain and support this work because the community needs it
- ISU does not make money on this effort, and often struggles to break even, but we are committed to these children and their families





University Commitment to the Project



- The Chestnut Building is a four-story, 40,000 sq. ft. brick building at 749 Chestnut Street
- Opened in 1971 to house the School of Nursing
- The current value of this building is \$9.3M
- Renovation is required to meet accreditation standards for early childhood programming
- The estimated cost to renovate the first two floors is \$6.5M
- Expanded capacity following this renovation would be approximately 145 children
- Future plans to complete the other two floors would further grow the capacity to serve more children
- We continue to pursue as many funding avenues as possible to make that happen
- ISU has already begun work with an architect on early design and cost projections to start the process

Our Vision

- "The data are clear. Early childhood programs that are sustained and high quality can have longlasting impacts on children, preparing them for formal schooling and beyond with the added factor that early education paves the way for parents to be in the workforce." (The Brookings Institution, 2021)
- Goal: every kindergartener is ready for learning when they go to school at age 5
- PTQ is Indiana's voluntary rating system for childcare providers
- Level 4 is the highest attainable rating
- The ISU ECEC programs have been recognized for 10 consecutive years as PTQ Level 4 (preschool license)
- 5 consecutive years as PTQ level 4 (infant/toddler license)
- High quality early childhood programming matters





Comprehensive strategic plan for childcare throughout our community



- ISU is using planning dollars from a Lilly Foundation Planning Grant working with Ivy Tech and RJL Solutions to bring the community together to draft a strategic plan for ECE in the region
- A well-crafted strategic plan will provide materials for the EDC to use in attracting businesses and manufacturers to Terre Haute
- Employers looking to locate in communities always ask questions about the housing availability, schools and certainly about quality early childhood care
- Terre Haute and the Wabash Valley have so much to offer corporations who are exploring sites to develop
- High-quality, research-based childcare facilities are a must to drive this kind of development



Timeline

Proposed Tentative Timeline:

- December 2023 all funds secured for the project
- January 2024 to March 2024 Complete programming, schematic design, and construction documents
- February 2024 ISU Board of Trustee approval of project
- March 2024 ICHE approval secured
- April 2024 State Budget Committee approvals secured
- May 2024 Receive bids for project
- June 2024 Begin renovation/construction
- March 2025 Substantial Completion
- April 2025 Owner Occupancy/Move-in
- May 2025 Completion of project


