RE: Request for Appropriation of Hydrite Reimbursement

On February 21, Hydrite Chemical in Terre Haute accidentally discharged high-strength ammonia product (Ammonium Bisulfite) into the municipal sewer system. This discharge, once reaching our wastewater treatment facility, damaged the biological microbes to such an extent that the facility could not treat the roughly 10 million gallons of wastewater received each day. Without proper treatment, this high strength wastewater had to be stored. The wastewater plant did not discharge from the main treatment facility to the Wabash River for more than three full days. The issue was discovered on February 22 and the wastewater personnel began working around the clock to restore the plant to its normal function and ensure no harmful wastewater was discharged into the Wabash River.

Hydrite Chemical agreed to reimburse the Wastewater Utility for all costs associated with the cleanup and reseedling of the biological microbes necessary to treat the incoming wastewater. The chart below shows the breakdown of costs by budget line. The reimbursement check from Hydrite for \$169,909.11 was received on April 4 and deposited into *Other Revenue (0620-0061-00-390.010)*. I am requesting these amounts to be appropriated into the original budget lines.
