#### Special Ordinance No. 4, 2024

AN ORDINANCE VACATING A PORTION OF 28th STREET, A PUBLIC STREET, LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA.

BE IT ORDERED by the Common Council of the City of Terre Haute, Indiana.

**SECTION 1**. Pursuant of the provisions of I.C. 36-7-3-12, it is desired and deemed necessary to vacate a portion of a public street, commonly known as 28<sup>th</sup> Street, located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:

Beginning at the northeast corner of Lot 68 in Commercial Club Place No. 2 (commonly known as 2736 Ft. Harrison Road), thence east to the northwest corner of Lot 49 in Commercial Club Place No. 2 (commonly known as Parcel 84-06-02-455-004.000-002), thence south approximately 140 feet to the southwest corner of Lot 49 in Commercial Club Place No. 2 (commonly known as Parcel 84-06-02-455-004.000-002), thence west to the southeast corner of Lot 68 in Commercial Club Place No. 2 (commonly known as 2736 Ft. Harrison Road), thence north approximately 140 feet to the point of beginning.
