# AN ORDINANCE VACATING A PORTION OF A PUBLIC ALLEY, LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA.

BE IT ORDERED by the Common Council of the City of Terre Haute, Indiana.

**SECTION 1**. Pursuant of the provisions of I.C. 36-7-3-12, it is desired and deemed necessary to vacate a portion of a public alley located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:

Beginning at the northeast corner of Lot 8 in Jewetts 1st subdivision (commonly known as 1311 Eagle Street) thence east approximately 12.5 feet to the northwest corner of Lot 7 in Jewetts 1st subdivision (commonly known as 1317 Eagle Street) thence approximately 197.4 feet south to the southwest corner of Lot 7 in Jewetts 1st subdivision (commonly known as 101 North 13<sup>th</sup> Street) thence west approximately 12.5 feet to the southeast corner of Lot 8 in Jewetts 1st subdivision thence approximately 197.4 feet north along the east side of 101 North 13<sup>th</sup> Street, 103 North 13<sup>th</sup> Street, 121 North 13<sup>th</sup> Street, and 1311 Eagle Street to the point of beginning.

**SECTION 2**. Be it further ordained that said portion of said public alley in the City of Terre Haute, Indiana, above described, be and the same is vacated and will revert to the abutting properties, subject to the continuation of any and all existing easement rights for public utilities.

**SECTION 3.** Be it further ordained that the City Clerk be, and he is hereby directed to furnish a copy of this Ordinance to the Recorder of Vigo County, Indiana, for recording, and to the Auditor of Vigo County, Indiana.
