RESOLUTION NO. 24, 2024**CITY CLERK****A RESOLUTION DESIGNATING THREE (3) MEMORIAL WAYS FOR THE BLOCKS
SURROUNDING GOLD MEDAL PLAZA**

WHEREAS, Gold Medal Plaza is a Terre Haute City Park located in 12 Points at the intersection of Lafayette Avenue, Maple Avenue and North 13th Street; and

WHEREAS, this park also includes a memorial to Terre Haute's three Olympic Gold Medal Winners: Dr. Gregory Curtis Bell, Terry Gilbert Dischinger, and Clyde Edward Lovellette; and

WHEREAS, Dr. Gregory Curtis Bell was a 1948 graduate of Garfield High School who won an Olympic Gold Medal for Broad Jump at the 1956 games held in Melbourne, Australia; and

WHEREAS, Terry Gilbert Dischinger was a 1958 graduate of Garfield High School who won an Olympic Gold Medal for Basketball at the 1960 games held in Rome, Italy; and

WHEREAS, Clyde Edward Lovellette was a 1948 graduate of Garfield High School who won an Olympic Gold Medal for Basketball at the 1952 games held in Helsinki, Finland, and

WHEREAS, the Terre Haute City Council wishes to honor the memory and achievements of these local athletes on the world stage.

BE IT THEREFORE RESOLVED, that the following, one-block sections of the below-listed streets bordering Gold Medal Plaza be designated as follows:

Maple Avenue, Dr. Gregory Bell Olympic Memorial Way

North 13th Street, Terry Dischinger Olympic Memorial Way

Lafayette Avenue, Clyde Lovellette Olympic Memorial Way

BE IT FURTHER RESOLVED, that the Board of Public Works and Safety, while not changing Maple Avenue, North 13th Street, or Lafayette Avenue's designation or signage, be directed to prepare and hang one gold sign with black lettering on each of the above-described blocks reflecting these Memorial Way designations.
