Please find attached a very basic/rough (worksheet) plat of the description of the property that is requesting to be rezoned.

The total number of acres being requested is 41.0 acres (see the breakdown in pencil along the margins of the legal description).

Simply speaking, the request encompasses 99% of the property of J & L Land Works LLC owns between Edgewood Grove to Ohio, and Brown Ave to Fruitridge. The only part not included is the small 0.82-acre (PN 308-001) in the Southwest corner.

I spoke in detail about this to Mr. Nation before the Council meeting last Thursday (May 8th).



## SPECIAL ORDINANCE NO. 18, 2025

CITY CLERK

An Ordinance Amending Chapter 10, Article 2 of the Municipal Code designated as "Comprehensive Zoning Ordinance for Terre Haute Indiana."

SECTION 1. BE IT ORDIANED BY THE COMMON COUNCIL of the City of Terre Haute, Vigo County, State of Indiana, that Chapter 10, Article 2 of the City Code of Terre Haute, designated as the "Comprehensive Zoning Ordinance for Terre Haute" and Division 4, Section 10.121 thereof, District Maps, be, and the same is hereby amended to include as follows:

That the following described real estate situated in the City of Terre Haute, County of

Vigo, State of Indiana, to-wit:

ROAD INTO EGROVE
