**Whereas** we acknowledge that conditions of work sites have improved since the passing of the Occupational Safety and Health act in 1970 and in the Indiana State Occupational Safety and Health Administration shortly after that; and

**Whereas** we remain committed to the on-going advocacy of labor activists in the city of Terre Haute to continue to improve the quality of the workplace through regular inspection and high standards of health and safety measures; and

**Whereas** we are aware that injuries, illnesses, and fatalities are not accidents but are avoidable and preventable; and

**Whereas** we support the call for good jobs, safe jobs and the protection of rights, and we pledge to seek ways to make these goals a reality; and

**Whereas** we honor the legacy of Eugene Victor Debs, who was proud to call the city of Terre Haute his home and was ahead of his time in his vision of equality and justice; and

**Whereas** we work at the local level, and we are conscious of the invisible, most vulnerable workers in our midst who have been left out of State and Federal workplace protections; and

**Whereas** it is altogether right to remember those workers by name and deed who went to work to labor for the community and did not come home.

**NOW THEREFORE BE IS RESOLVED**, we, the Terre Haute City Council, join city and county governments and leaders all over the United States that are gathering as we are to proclaim Sunday, April 27, 2025, to be

**Workers Memorial Day** in the City of Terre Haute.
