To Whom It May Concern:

I have asked for a few changes in the 2010 Budget. I would like to transfer \$49,995.00 from the Non-Reverting Training Fund to Search and Rescue. We received a State of Indiana Grant. This Grant was a reimbursable grant and the City of Terre Haute has already paid \$49,995.00 for the construction of a search and rescue house so this would be to "zero" that line item out, as it is now in the negative for this amount.

The second change is for \$1804.00 to be placed in the Search and Rescue line from Electric Utility and Office Supplies. In the second floor of this house, there is an open area for the purpose of having a "maze" built for the purpose of a SCBA confidence course. I have an invoice from a contractor for \$1,800.00 for the construction of this course and would like to have it constructed before the end of the year.

And last is an appropriation for \$44, 000.00 for the services of an Architect for the purpose of building a classroom building at the ERTA. This has been approved by the Board of Public Works and Safety and the financing will be sent. The services have been paid for already and the account Construction of a New Building is being held in the negative in the amount of \$43, 777.10. This appropriation would bring that account into the black by the end of the year.
