

SPECIAL ORDINANCE NO. 45, 2010

AN ORDINANCE AMENDING SPECIAL ORDINANCE NO. 13, 2009, TO AMEND THE SALARIES FOR THE WASTEWATER UTILITY HOURLY WORKERS FOR THE CITY OF TERRE HAUTE, INDIANA, FOR 2010, TO TAKE EFFECT ON JANUARY 1, 2010.

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Indiana:

SECTION 1. Pursuant to a Transit Utility arbitration award issued on November 12, 2010, and the "me too" clause in the collective bargaining agreement with the WWTP Department, the City is required to increase wages by 2.1%.

<u>SECTION 2.</u> Therefore, Special Ordinance No. 13, 2009, passed on September 10, 2009, is hereby amended by deleting the stricken text and inserting the underlined text as follows:

SECTION 1. Commencing January 1, 2010, the following salary schedule shall be in full force and effect for Wastewater Utility of the City of Terre Haute, as follows:

Maintenance Electrician \$ 18.64 \$	<u> 19.03</u>
Assistant Working foreman \$ 18.60 \$	18.99
Maintenance Department \$ 18.14 \subseteq	<u>18.52</u>
Collections Department \$ 18.14 \underset{\subset}\$	18.52
Construction Crew Department \$ 18.14 \underset{\subset}\$	18.52
Building & Grounds Department \$ 18.14 \subseteq 18.14	18.52
Operations \$ 17.37 <u>\$</u>	<u>17.73</u>

All new employees in each department shall receive 25¢ per hour less than regular hourly rate established for that department for the first ninety (90) days of their employment.

<u>SECTION 3.</u> All other remaining section of the original salary ordinance shall remain unchanged.

SECTION 4. The illegality or invalidity, for any reason, of any of the sections of this ordinance, or parts thereof, shall invalidate only such section or sections as are so determined to be illegal or invalid, and any such invalidity shall have no effect on the remaining sections of this ordinance.

SECTION 5. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 6. This amendment shall be in full force and effect from and after its passage and

shall be effective as in the salaries provided on and for January 1, 2010.
