## SPECIAL ORDINANCE NO. 47, 2011

## AN ORDINANCE VACATING A PORTION OF A PUBLIC STREET LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA STATE UNIVERSITY

BE IT ORDERED by the Common Council of the City of Terre Haute, Indiana.
SECTION I. Pursuant to the provisions of IC.36-7-3-12, it is desired and deemed necessary to vacate a portion of North $40^{\text {th }}$ Street located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:

Beginning at the northwest comer of lot 19, of Eastlawn Subdivision. As platted and recorded in the Vigo County Recorder's Office. Thence S-01* 49' 00"-E (Assumed bearing) Along the west line of lots 19 thru 27; thence $\mathrm{N}-89^{*} 51^{\prime} 00^{\prime \prime}$-W 50.00 feet to the southeast corner of lot 46; thence $\mathrm{N}-01^{*} 49^{\prime} 00^{\prime \prime}-\mathrm{E} 360.00$ feet to the northeast corner of lot 54. Thence $\mathrm{S}-89^{*} 51^{\prime} 00^{\prime \prime}$-E 50.00 feet to the point of beginning. Containing 0.41 acres more or less.

WHEREAS, Petitioner respectfully requests and petitions the Common Council of the City of Terre Haute, Indiana, after hearing on this Petition in accordance with law to:
a.) Adopt an Ordinance vacating that portion of the Public Street referred to and described above, subject to existing easement rights for public utilities:
b.) Cause the Clerk of the City of Terre Haute to furnish copies of said Vacation Ordinance to the County Recorder of Vigo County for recording and to the County Auditor, and to thereupon case the Recorder to release said Ordinance to the Vigo County Area Planning Department for distribution in accordance with the City's Zoning Ordinance and Subdivision Code.
c.) For all other proper relief in the premises.
