

SPECIAL ORDINANCE NO. 53, 2011

AN ORDINANCE TO AMEND SPECIAL ORDINANCE NO. 33, AS AMENDED, TO AMEND THE SALARIES AND BENEFITS FOR THE CERTAIN EMPLOYEES OF THE PARKS AND RECREATION DEPARTMENT FOR THE CITY OF TERRE HAUTE, INDIANA, FOR 2012, TO TAKE EFFECT ON JANUARY 1, 2012.

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Indiana:

SECTION 1. Special Ordinance No. 33, 2011, As Amended, passed on September 28, 2011, is hereby further amended to provide a 1% salary increase by deletion of the stricken text and insertion of the underlined text as follows:

“SECTION 1. Commencing January 1, 2012 the following salary schedule shall be in full force and effect for the following employees of the Parks and Recreation Department of the City of Terre Haute, as follows:

SECTION 2. Special Ordinance No. 33, 2011, As Amended, passed on September 28, 2011, is hereby further amended by deletion of the stricken text and insertion of the underlined text as follows:

SECTION 4.

(B) PERSONAL DAYS

Parks and Recreation employees covered by this ordinance shall received ~~four~~ (4) five (5) personal days with pay.

(C) SICK DAYS

Parks and Recreation Department employees covered by this ordinance shall receive ~~six~~ (6) seven (7) sick days with pay. Sick leave may be accumulated up to a total of forty-five (45) working days. Upon separation of employment with the City, employee shall be paid for all accumulated unused sick leave days.

SECTION 3. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and shall be effective as in the salaries provided on and for January 1, 2012.
