GENERAL ORDINANCE NO. 9, 2012

AN ORDINANCE AMENDING CHAPTER 8, ARTICLE 1, DIVISION III, SECTION 8-13, SIGNALIZED INTERSECTIONS – SCHEDULE D OF THE *TERRE HAUTE CITY CODE*.

SECTION 1. The *Terre Haute City Code*, Chapter 8, Article 1, Division III, Section 8-13, Signalized Intersections – Schedule D, is hereby amended by *deletion* of the following signalized intersection:




SECTION 2. THEREFORE, BE IT ORDAINED by the Common Council of the City of Terre Haute that the traffic signals located at the intersection of Chestnut and 7th Street shall be removed and the signals placed within the inventory of the Terre Haute Street Department.


SECTION 3. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.


