 - a. Leslie Ellis, City Controller, presented the Council a list of renewal dates for bargaining agreements and an accounts payable aging report. Mrs. Ellis responded to the council's questions.
 - b. Councilman Karrum Nasser commented the accounts payable aging report as presented was not what he requested. Councilman Nasser asked if the Controller was holding checks in her office.
 - c. Councilman Don Morris asked the price of a new financial software program.
 - d. Mayor Duke Bennett responded to Councilman Morris's question that the cost would be \$700,000 to \$800,000. Mayor Bennett responded to Councilman Elliott's questions concerning vendors.
 - e. Councilman George Azar asked if the stage date was the paid date.
 - f. Councilwoman Martha Crossen asked the Controller if a report could be prepared based on invoice date.
 - g. Councilman O. Earl Elliott asked if the report was for claims in all of the City's funds. Councilman Elliott also questioned a few of the claims listed.
