We live on the city's east side and/or we recognize the importance and significance to Terre Haute of the area surrounding Deming Park. We strongly oppose the rezoning and the development of apartments on the 15-acre tract of land bordered by Adams Blvd., Poplar, and Fruitridge, aka Beau Monde, for the following reasons:

- * The construction of apartments will diminish the value and quality of the Ohio Boulevard-Deming Park Historical District - a community asset.
- * Over population will exacerbate existing traffic problems in the area. The area serves as a significant recreational area for walking, running, and biking.
- * Home values will decline with the increased traffic and with the increase in noise.
- * It boils down to a fundamental question of what we value as a community and a neighborhood.
