Dear Terre Haute City Council Member,

I live in Edgewood Grove on the city's east side. I strongly oppose the rezoning and the development of apartments on the 15-acre tract of land bordered by Adams Blvd., Poplar, and Fruitridge, aka Beau Monde for the following reasons:

 The construction of apartments will diminish the value and quality of the Ohio Boulevard-Deming Park Historical District - a community asset.

- Over population will exacerbate existing traffic problems in the area. With all due respect to the south end, we don't want to be like the south end.
