- 3. Comment on non-agenda items.
 - a. Ed Dammon commented on the lack of help from State of Indiana for the City of Terre Haute and their financial situation.
 - b. John Abbinetti commented on how the salary of a police officer in the 1925 Police Pension Fund and their work environment.
 - c. Donald Hyde commented on the lack of communication between City of Terre Haute and Vigo County. Mr. Hyde also commented about the lifespan of government buildings.
 - d. Jerry Hoff commented on misappropriation of funds and the lack of investigation concerning the Police Pension Fund.
 - e. Don Tyler commented on retired police officers following the laws and that the Police Pension Fund should be untouched.
- 4. Corrections to journal.
 - a. Appropriation 5, 2017 was read into New Business with the incorrect dollar amount. Correction has been made and legal notice was sent with correct dollar amount.
- 5. Communications.
- 6. Reports from Governmental Agencies
 - a. Chief Deputy City Clerk, Michelle Edwards, commented on the schedule for the upcoming meetings for the 2018 Budget discussions and voting.
 - b. Special Meeting 9/7/17 at 5:00pm, Presentation by Umbaugh & Associates
 - c. Councilman O. Earl Elliott commented on a citizen's comments concerning Robert Clary and his health condition. He also commented on the 1782 Notice from the Department of Local Government Finance and the lack of communication and response from Mayor Duke Bennett. Councilman Elliott also commented on possible penalties for overspending the current budget. He stated he has been in contact with the Department of Local Government Finance concerning this situation. Councilman Elliott commented on the Sanitary Board's passage of bonds for \$85 million. He further stated he had received telephone calls concerning vendors not being paid on time. Councilman Elliott responded to Councilwoman Crossen's questions that he had not seen all of the correspondence and that a new law had been enacted changing the method for preparing budgets. Councilman Elliott responded to Councilman Azar's questions that the change did take place in spring of 2016 and he was unsure of why the administration did not apply it. He responded to Councilman Nation's question by stating he had attended a meeting and received a pack of information. He further stated that one of the documents contained in the packet was a copy of the 1782 notice.
 - d. Councilman Neil Garrison asked why the Council was not informed earlier of the current year's budget reduction from the Department of Local Government Finance. He asked if Council President Karrum Nasser could contact them to set up a meeting.
 - e. Council President Karrum Nasser stated the Department of Local Government Finance had stated they would meet with the Council to discuss the situation. He responded to

- Councilman Morris's question that Mayor Bennett had stated there would not be a special meeting with Umbaugh and Associates earlier than originally planned. He asked Eddie Felling, City Attorney, about any penalties from overspending the budget.
- f. Councilwoman Martha Crossen asked Councilman Elliott if he received copies of the correspondence with Department of Local Government Finance and State Board of Accounts. She also question the method the administration used to prepare the 2017 budget. Councilwoman Crossen commented on the City's ability to reduce the budget and still retain all of the employees.
- g. Councilman Don Morris asked if a special meeting could be held to meet with Mayor Bennett to discuss this. He stressed the urgency of meeting sooner rather than later.
- h. Councilman George Azar questioned Councilman Elliott about the change in budget preparation started in 2016. He also asked why the administration did not apply the new law to the 2017 budget. Councilman Azar also questioned why the Council was not informed earlier about the 1782 notice.
- i. Councilman Todd Nation asked Councilman Elliott how he became aware of the 1782 notice and required budget reduction.
- j. Councilman Curtis DeBaun IV stated the Council needs answers and asked why Mayor Bennett did not attend this meeting tonight.
- k. Eddie Felling, City Attorney, responded to Council President Nasser's question concerning overspending the budget.
