

SPECIAL ORDINANCE NO. 2, 2017

AN ORDINANCE TO FURTHER AMEND SPECIAL ORDINANCE 26, 2016, AN ORDINANCE SETTING THE SALARIES OF "PARKS AND RECREATION DEPARTMENT" EMPLOYEES, EFFECTIVE JANUARY 1, 2017.

WHEREAS, Special Ordinance 26, 2016 was passed on October 14, 2016; and

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Indiana:

**SECTION 1.** That Special Ordinance 26, 2016 is hereby amended by addition of the underlined text and deletion of the stricken text as follows:



be illegal or invalid, any such invalidity shall have no effect on the remaining sections of this ordinance.


**SECTION 3.** All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
