**Community Collaboration Committee welcomes Superintendent Haworth**

Collaboration was the word of the day at the Community Collaboration Committee's meeting, August 13, 2018. With the introduction of the new superintendent, Robert Haworth, Ph.D., attendees representing the County and the City were pleased to hear that Haworth understands the importance of working together to benefit the community. Other topics of discussion included workforce development, community planning, and strategies for population growth.

"I think it's admirable that the County has asked the School Corporation to come to a meeting to talk about community projects," Haworth stated when addressing the goal of the committee.

The Community Collaboration Committee was formed in October 2017 in an effort to be more proactive in educating one another on decisions affecting the community. The County Commissioners designated RJL Solutions to facilitate the group meetings.
