## Transit System Rules

Passengers and guest are required to follow at all times system rules while on transit system property, and/or while riding the transit system buses.

Passengers who disregard these rules may be removed from transit system property and buses by police or denied service and/or held criminally or civilly liable for his/her actions.

- 1. All riders are required to pay the appropriate fare and present ID for any discounted fares, and transfers are to be asked for at the point of payment, not when exiting the bus.
- 2. Front seats are reserved for ADA disabled passengers and the elderly.
- 3. Mobility devices must meet ADA guidelines and be secured only by the driver.
- 4. Children must be removed from strollers while riding on the bus.
- 5. Strollers must be folded up and removed from aisle.
- 6. Passengers must never cross in front of the bus after exiting.
- 7. Passengers must follow driver and City Bus staff instructions.
- 8. Animals "other than service animals" are prohibited while riding the City Bus.

- 9. No loitering on any City Bus or transit system property, which includes:
- a. Remaining on the bus for more than one complete trip/run or remaining at transit system property for more than one hour without being ticketed for Greyhound or Miller transportation.
- b. Being present on the site of transit system property more than 15 minutes before services have commenced for the day or more than 15 minutes after services have ceased for the day.
- c. In the event you must remain on a bus for more than one complete trip/run and pass the point that you boarded, additional fare will be required.
- 10. The following are prohibited:
- a. Open containers of food &/ or non-alcoholic drink will only be allowed if by medical necessity.
- b. Possession of any unlawful weapons or illegal substances on transit system buses or property.
- c. Damaging, defacing, or the destruction of transit system buses, equipment, facilities, or transit system property.
- d. Any attempt to steal transit system property or that of another transit system rider/guest or transit system employee, or to maliciously destroy property belonging to the transit system including transit system

riders/guest.

- e. Creation of any public disturbance including the use of obscene language, deviant behavior, threatening, or abusive behavior, whether in general or directed at any specific person or persons.
- f. Offensive smells or sounds that constitute a nuisance.
  - g. Sleeping on/at transit system property.
- h. Smoking, vaping, or use of tobacco products in and around transit system property and buses.
- i. Cylinders of propane or other gases, excluding medically required oxygen.
- j. Liquid fuel, such as gasoline, kerosene, and other lighting fluids.
  - k. Previously used gasoline containers.
- l. Liquid batteries (such as car batteries)
  Batteries used for ADA mobility devices and
  sealed batteries, such as lithium ion batteries
  are permitted on-board.
- m. Bulky items that obstruct the aisle such as e-scooters, bicycles, furniture items, etc.
  - n. Liquid chlorine and bleach.
- o. Spray paint, turpentine and other paint stripers.
  - p. Explosives
- q. Non-legal fireworks (as defined by local and state law)

"Note" transit system Management exclusively reserves the right as to the enforcement of transit system rules. Transit System Rules may be amended or modified, as the Transit System Management deems necessary.
